2. Invoices are payable within one month of issue.
3. In the case of disc jockeys, primary responsibility will be on the owner of the premises.

4. Audio visual tariff shall include actors' tariff.
5. The license shall not include events for raising funds, churches or other charitable causes.
6. Community and institutional broadcasting stations as well as TukTuks and Boda Boda are exempted from this tariff.

EXCLUSION

THE PROPOSED ACQUISITION OF CONTROL OF THE LSG  
GROUP BY AURELIUS INVESTMENT LUX ONE S.A.R.L

IN EXERCISE of the powers conferred by section 42(1) of the Competition Act, 2010, the Competition Authority excludes the proposed acquisition of control of the LSG Group by Aurelius Investment LUX One S.A.R.L from the provisions of Part IV of the Act due to the following reasons—

- (a) the merger will not affect competition negatively;
- (b) the acquirer had no assets in Kenya for the preceding year 2021, while the assets of the target were valued at KSh. 595,380,314;
- (c) the combined value of assets of the parties which is higher than the turnover was 595,380,314 which is above KSh. 500 million but less than KSh. 1 billion; and
- (d) the transaction meets the threshold for exclusion as provided under the Competition (General) Rules, 2019.
